1. WELCOME AND INTRODUCTION

The meeting commenced at 1:05 pm. Jenny Martin {JLM} welcomed all to the meeting, established there was a quorum and confirmed voting delegates. The meeting agenda was coordinated and run by ERTT, and minutes were taken by JLM.

2. MINUTES OF THE PREVIOUS MEETING

The minutes of the previous meeting held on Thursday, December 5th, 2018, 1:10 – 14:10, in Lecture Theatre 260-055, Conference Venue, were approved. The approval was proposed by Chris Ling, seconded by Sangho Lee and passed by Council.

3. MATTERS ARISING: IUCr ARCHIVE SERVICE (COSTS) FOR AsCA ABSTRACTS {JLM}

MINUTES OF THE ASCA COUNCIL MEETING - SINGAPORE - 2019

JLM reported on the IUCr initiative concerning the archiving of AsCA Abstracts with the assignment of a DOI. The cost would be USD 2,000 per Conference. It was resolved (moved by $\frac{X}{X}$ and seconded by $\frac{X}{X}$) that this policy be adopted for AsCA2021. Further consideration for archiving Abstracts from previous AsCA meetings was deferred.

4. MATTERS ARISING: DISTRIBUTION OF FUNDS (SHARING OF PROFITS) FOR SCANZ-HOSTED MEETINGS {JLM}

After discussion, the following motion:

"Profits/losses from jointly badged AsCA/local society conferences will be shared equally (50 AsCA:50 Local). The Local Organising Committee (LOC) for such conferences may choose to divide the local share of the profits/losses with a local University if that University has provided significant in-kind support and underwritten the event.

Should a proposed AsCA conference be anticipated to be jointly badged with a local society, or should there be any variation to this policy, this information must be outlined at the time of bidding for the conference so that Council may vote with that knowledge in mind. The proposed arrangements must also be agreed to by the local Society and University.

It is a requirement of all AsCA conferences that accurate accounts are kept and that a draft Profit/Loss statement is provided by the LOC a month or two before the conference, a final draft reported at the Council meeting at the conference, and a final report submitted within 6 months of the event (the final report would normally be audited by the professional conference organiser or a similar external/independent organisation)."

was moved by Charlie Bond, seconded by Sammer Yousef, and accepted by Council.

5. AsCA FINANCIAL REPORT

The statement of finances was prepared by Mark Spackman on behalf of the AsCA trustees, Mark Spackman, Alice Vrielink and Charlie Bond, all based at the University of Western Australia, and presented to Council by ERTT:

Acceptance of the report was moved by Xiao-Dong Su, seconded by Kurt Krause and accepted by Council.

Subscriptions for category B members: JLM moved that the current policy "Category B members should pay the fee if they were able, but could retain membership if they made the case that they were unable to pay." Seconded by Ruchi Anand. This motion was approved by Council.

6. GENDER EQUITY AND DIVERSITY POLICY {JLM; ERTT – ASCA2019 SUMMARY} Jenny Martin reported that the IUCr is establishing a gender equity and diversity committee to ensure that all IUCr activities are inclusive.

A summary of participation at AsCA2019 was presented by ERTT based on the statistics provided by the "PCO". While there are discrepancies, for example, the "PCO" was not able

to identify the Nationality of two male (M) delegates, the broad numbers are reflective of the participation at AsCA2019.

The conference attracted a total of 526 registrants (inclusive of Exhibitors) from 29 countries with a Female (F):M breakdown 161:365.

By country, delegates (484 less 2) were drawn from: Australia 28, Austria 1, Bangladesh 3, Belgium 1, China 46, Croatia 1, France 3, Germany 8, Hong Kong 8, India 68, Indonesia 1, Japan 93, Korea 64, Malaysia 9, Mongolia 1, Netherlands 3, New Zealand 6, Pakistan 2, Russian Federation 3, Singapore 55, South Africa 1, Sri Lanka 2, Sweden 2, Taiwan 35, Thailand 13, United Arab Emirates 2, United Kingdom 18, United States 5.

Michael Parker reported that a PCO has been appointed and that arrangements are being made for advertising IUCr 2023 during Prague 2020.
