2. MINUTES OF THE PREVIOUS MEETING

The minutes of the previous meeting held on Monday, December 6th, 2016, 12:30 – 13:150, Room 702, Ta Quang Buu Library, Hanoi University of Science and Technology, Hanoi, Vietnam and circulated by e-mail by the Secretary/Treasurer, J J Vittal, were approved. The approval was proposed by Kurt Krause, seconded by Atlat Hussain and passed by Council.

3. AsCA FINANCIAL REPORT

The statement of finances was prepared by Mark Spackman on behalf of the AsCA trustees, Mark Spackman, Alice Vrieling and Charlie Bond, all based at the University of Western Australia, and presented to Council:

Acceptance of the report was moved by JJ Vittal, seconded by Kurt Krause and accepted by Council.

Subscription update: Australia and Japan have not yet paid their subscriptions. Chris Ling (SCANZ) and Genji Kurisu (CSJ) to follow up.

Subscriptions for category B members: Kurt Krause moved that Category B members should pay the fee if they were able, but could retain membership if they made the case that they were unable to pay. Seconded by Jenny Martin. This motion was approved by Council.

4. PROPOSAL FOR CAMBODIA TO JOIN ASCA

Bun Kim Ngun (Cambodia) made a case to join AsCA as a category B member, and made the case that they would be unable to pay the Category membership fee. Membership was approved by Council and the inability to pay the fee was noted. Cambodia would be nominated in the IUCr regional committee from Asia (fees paid by AsCA) now that Bangladesh and Singapore have become full members of IUCr.

5. PROGRESS REPORT FOR AsCA 2018 (15TH AsCA CONFERENCE, AUCKLAND, NEW ZEALAND)

Chris Squire LOC chair and Ted Baker IPC chair presented the progress report and noted potential competition for delegates with a MOF conference scheduled soon after. - a) Future meetings of AsCA – 2022 {JLM} – AsCA Council members are encouraged to bid for the 2022 conference, at the next AsCA council meeting to be held in NZ in Dec 2018
- b) World Directory of Crystallographers {JLM} – IUCr strongly urges member organisations to encourage their members and colleagues to sign up to this directory to help organisers of AsCA and IUCr conferences to identify potential speakers, committee members etc.
- c) Adherence to IUCr policy of broad representation {JLM} – IUCr has strengthened its policy on representation and urges its member organisations to implement actions to address diversity - especially gender equity - in conferences. This was discussed, and a first step is to define the conference policy and make the policy public on the conference website, and report on the data, e.g. number of women and men attendees, number of women and men members of LOC and IPC committees, number of women and men invited KN and PL speakers, MS chair and MS speakers. The Program chair of the next AsCA meetings (NZ and Singapore) were encouraged to follow the lead of the recent SCANZ conferences that make their policy public and report diversity data on the website.
- d) An interim report of 14th AsCA (Hanoi) was presented to the Council by Duong Ngoc Huyen. The conference is close to break even.
- e) Societies/countries wishing to propose to host an AsCA meeting in 2022 or beyond are invited to do so during AsCA 2018.

The next Council meeting will be held during AsCA 2018 in Auckland.
